Short term rental ordinance reconsidered

Fort Worth City Council is beginning the process of reconsidering its ban on short term rentals of less than 30 days. Short-term rentals are better known as Airbnb or VRBO properties offered to visitors for weekends or short stays. Investors are buying homes in single family neighborhoods and converting them to this type of property despite the prohibition on such activity. Fort Worth has not enforced its ban unless neighbors complain. Now the city led by Mayor Mattie Parker is getting serious about adapting to a changed environment for single family neighborhoods.

Many options are on the table that would regulate these properties or restrict them to certain zones in the city. Public Improvement District 2021 Report

Daniel Haase, Public Improvement District Board Member, provided a 2021 <u>year-end report</u> on improvements in East Fort Worth and <u>reduction in vagrants</u> along East Lancaster. East Fort Worth's PID security team is adds an extra layer of protection to the East Lancaster corridor.

Central Hotel on East Lancaster

Ongoing criminal activity at Central Hotel, 5800 East Lancaster, has drawn a response from the city. On January 12, 2022, a letter was sent from the city attorney's office requesting a formal meeting with the owner of the motel. Once a meeting has been scheduled, the city attorney's office and FWPD will meet with owners to discuss options for abate crime at this location and the recourse the motel faces owners do not comply with requests and criminal activity continues.

In the event owners do not comply with the city/PD requests, a petition would be filed to temporarily and/or permanently shut down the hotel.
