

# Two Properties on Meadowbrook Drive to be Rezoned

Two vacant commercial properties, 3626 and 3629 Meadowbrook Drive, are to be considered for rezoning in September after a lengthy campaign by neighborhood associations in Central and West Meadowbrook to resolve the lingering issues around the properties. The City of Fort Worth reclaimed 3626 Meadowbrook Drive in 2012 for back taxes after a daycare center located on the property failed. The property has been zoned ER for light commercial since the 1940s. On Wednesday, Sept.14, the Zoning Commission will decide whether to rezone 3626 Meadowbrook as single family. The 3629 Meadowbrook property, a vacant gas station, across the street from 3626 Meadowbrook will also be rezoned later at the request of the owners. To participate in the Zoning Commission process for 3626 Meadowbrook, please send a message supporting single family zoning including the case number (ZC-22-149) and 3626 Meadowbrook in the subject line to zoninglanduse@fortworthtexas.gov or sign up to speak at the commission meeting. Once the land is rezoned single family, 3626 Meadowbrook will be offered to the public for sale to the highest bidder. Single family zoning gives the neighborhood a voice in what is built or operated on 3626 Meadowbrook.

A slate is presented in October and elections are in November. Monthly council meetings are hybrid to fit busy schedules and quarterly membership meetings are in the evenings. Last year WMNA sponsored two neighborhood services nominated events, with the National Night Out community crime prevention gathering winning in one category. Officers with WMNA collaborate closely with members and city leadership to shape zoning, policy, and crime prevention.

## **Illegal Parking Problem Addressed**

Illegal parking at Brentwood Stair and Interstate 30 may be resolved after Central and West Meadowbrook Neighborhood Association leaders complained about the use of a Texas Department of Motor Vehicles construction staging area as an unauthorized neighborhood parking area. State Rep. Nicole Collier intervened with help from the Fort Worth Police Department and Texas Department of Motor Vehicles to press for installation of barricades and towing of violators on land near an exit ramp off Interstate 30. Near accidents caused by drivers attempting to enter the property across traffic on Brentwood Stair may finally be fixed thanks to the efforts of WMNA Civic Affairs Chair Mike Phipps, Central Meadowbrook Vice President Dan Haase, state and local public servants and Collier. This action is an example of neighborhood associations partnering with agencies to make lives better for all residents.
